BROOKWOOD TRANSPORTATION AGREEMENT AND RELEASE

| This AGREEMENT is made and entered into by and between the Norwalk-Ontario-Wilton School District (hereinafter "School District:) and, the parent(s) or legal guardian(s) of (hereinafter referred to as "student"), a student at Brookwood High School / Junior High within the school district concerning transportation of the student to and from the following school activity:, on, 20 |

| 1. The parent or legal guardian and student are informed and acknowledge that the District will provide and has offered to provide transportation for the student to and from the activity. |
| 2. Although transportation will be provided for the student, the parent or legal guardian nonetheless requests the authorization of the school district to allow alternate transportation for the student from the student activity even though the District does provide transportation from this activity. |
| 3. The parent or legal guardian and student acknowledge and agree that the school district has not requested or required that the parent or legal guardian provide transportation for the student either to or from the student activity described above. |
| 4. The parent or legal guardian and the student are informed and acknowledge that the school district has and assumes no responsibility for the supervision, safety, and welfare of the student when the student is in the care and custody of the parent, legal guardian, or designated driver as named below, to include transportation of the student from student activities. |
| 5. The parent or legal guardian and student are informed and acknowledge that the District does not carry or provide group or individual insurance coverage which will provide compensation for potential claims arising out of transportation of the student to and from the student activity through alternate means, not provided by the school district. Potential claims include, but are not limited to, claims for personal injury, medical expenses and property damage. |
| 6. The parent or legal guardian and student certify and agree that the student will be transported personally by the adult age 21 or older named here:, and that transportation will not be provided by the student or any other third person, not identified by this agreement. |

- 7. The parent or guardian certifies that the transporting adult possesses a valid State of Wisconsin motor vehicle operator's license, and is at least 21 years of age.
- 8. The parent or guardian certifies that the transporting adult will follow the athletic code rules for "signing out" the student following the activity.
- 9. In consideration of the school district authorization of the parent, legal guardian, or designated adult over 21 years of age to provide alternative transportation for the student, as set forth above, the parent or legal guardian, individually, and on behalf of the student does release and forever discharge the school district and its Board of Education, their officials, agents, officers, and employees, and their successors, individually and in the official capacity, from all claims, rights, chances of action, damages and demands whatsoever, including but not limited to all liability and judgments for claims of personal injury, known or unknown, damage costs or expenses of any which the parent or legal guardian and/or student may have against any and all of the foregoing entities and persons, arising out of, relating to, concerning or in any way connected with transportation of the student by the parent or legal guardian in connection with the student activity, described herein, and under the circumstances, set forth above.
- 10. The parent or legal guardian and student represent that they have read this agreement and understand it, that they have had a sufficient period of time in which to consider it and that they voluntarily accept the terms of this agreement.
